Online application Registered through (<https://admission.mjpruiums.in>) are invited for admission for LL.M. (Self-Finance), LL.M. (Cyber Law) (Self Finance), LL.M. (Human Rights and Duties), (Self Finance) courses for the session 2024-25 and onwards in the University Campus, MJPRU subject to fulfilling the following eligibility criteria:

1. The admissions shall be done exclusively through entrance examination based on the merit of qualifying LL.M. entrance examination 2024-25.
2. Preference of course is to be filled for each programme for which you are willing to apply at the time of counselling.
3. The Candidate must have cleared Graduation (LL.B./B.A.LL.B. or Equivalent) with 50% marks (for General and OBC) and relaxation of 5% for SC/ST Category as per U.P. Government rule.
4. Weightage marks shall be provided as per university admission rules.
5. Reservation of seats (both vertical and horizontal) shall be as U.P. Government norms.
6. For OBC candidates, the recent valid caste certificate (with non-creamy layer declaration) not older than 01-04-2021 shall be required.
7. The candidates are advised to visit regularly the University **website: [www.mjpru.ac.in](http://www.mjpru.ac.in)** for latest updates. The online application and registration forms are available on the University website. No application shall be entertained by hand.
8. Candidates selected for counseling according to Entrance Exam shall be required to report the respective law department, MJPRU (as directed in due course) along with all original mark sheets, registration form and caste certificate for verification (One self attested copy of each document is to be submitted).
