In case the candidates are not able to produce the certificates at the time of counselling, it will automatically lead to shift of their rank and accordingly they will be entertained as per revised rank without weightage.
- 4. Five (5) passport size Photographs.
- 5. For OBC candidates, the recent valid caste certificate (with non-creamy layer declaration) not older than 01-04-2022 shall be required.

- 6. A self-attested hard copy of online application form filled by the candidate.
- 7. The fee for PG Diploma courses/Diploma Courses 1st Semester is Rs. 15,000/- per semester and the same has to be deposited after admission in the department in form of DD (demand draft) in favour of Finance Officer, M.J.P. Rohilkhand University, Bareilly or through cash counter MJPRU.
- 8. Reservation will apply as per U.P. Government norms.
