Subject: Admission Notice for LL.M. (General), LL.M. (Cyber Laws), LL.M. (Human Rights and Duties), LL.M. (Self-Finance), LL.M. (Business and Corporate Laws), LL.M. (Executive) courses for the session 2025-26 and onwards in the University Campus, MJPRU.

All those Candidates who have registered Online through (https://mipruadm.samarth.edu.in/index.php) and have appeared for the University Entrance Test are invited for Counselling for admission in LL.M. (General), LL.M. (Cyber Law) (Self Finance), LL.M. (Human Rights and Duties), LL.M. (Self-Finance), LL.M. (Business & Corporate Laws), LL.M. (Executive) courses that are being offered in the University Campus for the session 2025-26 and onwards, subject to fulfilling the following eligibility criteria:


- 1. The admissions shall be done exclusively through entrance examination based on the merit of qualifying LL.M. entrance examination 2025-26.
- 2. Preference of course is to be filled for each program for which you are willing to apply at the time of counselling.
- 3. The Candidate must have cleared Graduation (LL.B./B.A.LL.B. or Equivalent) with 50% marks (for General and OBC category) and for SC/ST candidates, pass with 45% (a relaxation of 5% to SC/ST Category) as per U.P. Government Norms.
- 4. Reservation of seats (both vertical and horizontal) shall be as U.P. Government norms.
- 5. For OBC candidates, the recent valid caste certificate (with non-creamy layer declaration) not older than 01-04-2022 shall be required.
- 6. Candidates selected for counseling according to Entrance Exam shall be required to report to the Venue for Counselling, Law department, MJPRU along with all original mark sheets,

- registration form and caste certificate for verification (One self-attested copy of each documents is to be submitted) along with 5 Photographs.
- 7. Merely calling for counselling will not guarantee for admission. The admissions shall be done exclusively based on Entrance Exam merit and shall be closed as soon as the seats are filled.
- 8. The date of counselling is:
 - For Open Rank 1 to 400- 07th August 2025
 - For Open Rank 401 Onwards- 08th August 2025
- 9. Venue: Department of Law (Faculty of Legal Studies building), MJPRU Campus, Bareilly
